SPECIAL CONDITIONS

(Please choose the departments that suit you by looking at the special conditions of the department you would prefer. Students can not enroll on a department of which they do not have the special conditions even if they are admitted.

- 1. Having at least 70 points as Turkish language grade,
- **2.** Having had a high school biology course and a grade of achievement of 65% or more.
- **3.** Candidates to be enrolled are required to obtain a medical committee report from a full-fledged hospital (State Hospital or Faculty of Medicine hospitals) certifying that they do not have physical and mental disabilities which may prevent them from carrying out their professions during and after the training period.
- **4.** A one-year foreign language preparation program on quota basis is available for students who wish to study. (regardless of the quota for some universities). The duration of the preparatory program is not included in the years shown in the column of the course duration.
- **5.** Students may register the departments they have been admitted to on condition that they take the Special Talent Examination and become successful.
- 17. Students who are enrolled in this program and who can not complete the preparation class successfully within two years are dismissed from the program. Students who have failed the preparatory course in the preparatory class can enroll on an equivalent Turkish medium program in their own higher education institutions. However, according to 521 2016-ÖSYS PREFERENCE GUIDANCE, if these students prefer, beginning from their enrolling year they can be placed for once to a Turkish medium program by Assessment Selection and Placement Center on condition that their relevant OSYS scores should not be lower than the base point of the program they will be placed.
- **38.** Students who will be enrolled in this program are obliged to wear the uniforms required by the profession in practical courses.
- **46.** One-year English Preparatory Program on quota basis is available for students who wish to study. The duration of the preparatory program is not included in the years shown in the column of the course duration.
- **49.** The qualifications required to perform CIVIL AVIATION CABIN SERVICES (associate degree) profession are: 1) Not to have a criminal record. 2) To have a height of between 160 cm and 180 cm for the ladies (the weight being at most 5 kilograms more or 15 kilograms less than the last two digits of the height expressed

in centimeters). 3) To have a height of 170-190 cm for men (the weight being at most 5 kilograms more or 15 kilograms less than the last two digits of the height expressed in centimeters). 4) Health status should be suitable for flight (It is required to get a report from medical institutions authorized by the General Directorate of Civil Aviation confirming that the person's health condition is suitable for flight). 5) There should be no tattoos. scars, etc. seen when the cabin uniform The qualifications required to perform the AIRCRAFT TECHNOLOGY (Associate) profession are: 1) Not to have any Criminal Record that would prevent getting an airport entrance card. 525 2016-OSY PREFERENCE GUIDANCE 2) To get a health report from a full-fledged hospital certifying that the person does not have any health problems which may prevent him/her from carrying out his/her profession and duties.(color blindness, hearing loss, vision loss, etc.)

- **61.** One-year English or German Preparatory Program on quota basis is available for students who wish to study. The duration of the preparatory program is not included in the years shown in the column of the course duration.
- **121.** One year of compulsory Arabic Preparatory Program is carried out. The preparatory class is not included in the years shown in the column of the course duration. Those who pass the Arabic Proficiency Test will be taken directly to the first semester. The provisions of the "Regulations on the Principles to be followed in Foreign Language Teaching and Immersion Programs in Higher Education Institutions" are applied to the students.
- 233. Students who will be admitted to this program should obtain a report from their state or university hospital which certifies that they are healthy, both phisically and mentally, enough to get a driving licence. (the student's height and weight must be stated in the report) As the second-year students have to drive a vehicle, they must have turned 17 years old at the time of registration; must not be shorter than 1.65 m for male students and 1.60 m for female students, and the weight should be at most 5 kilograms more or 15 kilograms less than the last two digits of the height expressed in centimeters; when working on a team of two for rescue and transportation works, they need to have physical fitness in order to carry a patient on a stretcher with their teammate.
- **708.** The medium of instruction in this program is at least 30% Arabic.
- **762.** In order to apply for this program, in addition to all the requirements of the Council of Higher Education, it is necessary to be under 21 on 1st January 2018; to get parental consent for minors; not to have any physical or mental distorders that may prevent flying; not to stutter, lisp, etc.; not to take negative grades from interviews and tests made within the institutions determined by the university in order to measure the candidates' psychological, perception-decision making abilities in preregistration. Except for negligent traffic offenses, those who have criminal records will not be enrolled.

In this program, some courses and internships for practice are carried out at the premises of private and public aviation organizations, so for those who are entitled to start this program, criminal record inquiry will be required. Except for negligent traffic offenses, those who have criminal records will not be enrolled.
