





COOPERATION PROTOCOL BETWEEN UŞAK UNIVERSITY LEATHER, TEXTILE AND CERAMICS DESIGN, APPLICATION AND RESEARCH CENTER

AND

JOHANNITER-UNFALL-HILFE E.V.

1- Parties that have signed the Protocol

The parties to this protocol are Johanniter-Unfall-Hilfe e.V., Competence Center EU Civil Protection and Disaster Assistance and the Uşak University Leather, Textile and Ceramics Design, Application and Research Center.

2- Purpose of the Protocol

The purpose of this protocol is to effectively and efficiently carry out design, education, scientific, technical, improvement activities between Johanniter-Unfall-Hilfe e.V., Competence Center EU Civil Protection and Disaster Assistance and Uşak University Leather, Textile and Ceramics Design, Application and Research Center, to investigate the results with scientific methods, and to develop, implement, and evaluate work programs.

3- Scope

The protocol covers the activities of goodwill-oriented cooperation between Johanniter-Unfall-Hilfe e.V., Competence Center EU Civil Protection and Disaster Assistance and the Uşak University Leather, Textile and Ceramics Design, Application and Research Center, operating in the field of design, scientific and technical (specification preparation and revision, etc.) and carrying out joint projects in line with the above-mentioned purposes.

4- Definitions

In this protocol;

- a) DTS Design Center: Usak University Leather, Textile and Ceramics Design Application and Research Center,
- b) rescEU EMT: EU-funded project of Johanniter-Unfall-Hilfe e.V., Competence Center EU Civil Protection and Disaster Assistance are expressed.

5- Responsibility

- **5.1.** In the implementation of this protocol, the parties are equally responsible.
- **5.2.** Duties and responsibilities of the parties in the implementation of the provisions of the protocol are as follows:
- a) Duties and responsibilities of rescEU EMT:

- (1) Arranging the necessary environment and assisting in the workflow for the efficient work of faculty members, technical staff, and students participating in courses, training, and all other activities.
- (2) Allowing the exhibition of products, prototypes, etc. arising from the collaborative work with the DTS Design Center.
- (3) Creating appropriate environments when necessary for joint declarations, articles, exhibitions and fashion shows,
 - (4) Sharing information for joint studies in the field of design,
- (5) Signing and adhering to confidentiality and project (design, service work, training, consultancy, etc.) agreements mutually determined and agreed upon,
- (6) Permitting the use of rescEU EMT visual identity and/or name in advertising and news activities conducted by Uşak University,
- (7) Covering the costs of all kinds of design, scientific, technical, and improvement activities within the scope of the protocol.
 - b) Duties and obligations of the DTS Design Center:
- (1) Conducting design, education, scientific, technical, and improvement activities in collaboration with rescEU EMT,
- (2) Using the name and/or visual identity of rescEU EMT in the advertising of the results obtained in collaboration with rescEU EMT, subject to compliance with relevant regulations and obtaining necessary permissions,
- (3) Signing confidentiality and project agreements for mutually determined and agreed-upon activities,
- (4) To ensure that the infrastructure of the DTS Design Center is made available to the use of rescEU EMT, in line with confidentiality and project agreements, provided that the necessary permissions are obtained,
- (5) In joint projects with Uşak University, it is stated that they are carried out together with the DTS Design Center, and in the exhibition of the designs developed together or realized by the DTS Design center, the visual identity determined by rescEU EMT are exhibited together with the design exhibited, exhibited and presented at the fair,
- (6) Due to this agreement, no liability can be imposed on Uşak University under any name, including compensation related to intellectual and industrial rights. The parties will separately agree on the intellectual and industrial rights within the scope of the relevant legislation.

6- Amendment, review and additional protocol

Disputes that may arise in the implementation of this protocol shall be resolved by joint review and decision of DTS Design Center and rescEU EMT. If either party proposes a change to the protocol, they shall notify the other party of their proposal in writing. The requested changes shall be made by joint review and decision of DTS Design Center and rescEU EMT.

7- Executive

DTS Design Center and rescEU EMT carry out the works and transactions stated in the protocol together in line with their own obligations.

8- Settlement of disputes

Disputes that may arise in the implementation of this Protocol shall be resolved between the parties within the framework of good faith, mutual understanding and compromise.

This protocol consists of 8 (eight) articles and comes into force from the date of signing and continues unless either party gives a written notification regarding the termination of the protocol. Date 05/08/2024
